The February minutes were approved.

- Spirit bags were distributed to the Winter athletes similar to what the Booster Club did for Fall athletes. We will be doing similar bags for the next few seasons
- Booster Bash was discussed. The current Covid situation is still in flux and while we did discuss
 the event, we continue to hold off making plans on it until we can decide if it is safe to hold an
 event.
- Senior Banquet was discussed and it is still on hold.
- Booster Club gives out scholarships. Nomination forms go out to all the Coaches and they
 nominate student athletes. Then the head coaches meet up and decide who receives awards
 and the scholarships are awarded from these nominations.

Athletic Director

- The athletic training room has been renovated by D225. While it is mostly completed, we are still holding off on ordering the tables. Director Catalano is waiting on color samples. He is also working on new signage for the room. There was a motion to approve tables for the training room. Motion was approved for \$5,300 as a donation from the Booster club to pay for the new tables.
- We are working through the issue of fan attendance at athletic events, especially for the football games. We are allowed by the State of Illinois to have 20% of stadium capacity filled for the football games. Indoor sporting events will still have limited spectators and be ticketed events.
- We are also trying to stream some of the events so fans can watch remotely, including Football games.
- We only had 1 complete team be quarantined during the Winter season. We had a few individual athletes quarantining. Each week the saliva testing finds a few inconclusive tests. Some have turned out to be positive, but not all.
- We do have a facility issue when all the sports will start to overlap. We have taken over some of the Park District fields to help with the overlap. The Park District has been very helpful in finding us extra fields to utilize.
- We have 14 coaches that are overlapping sports teams. They are working incredibly hard to support our student athletes.
- IHSA has said they are having a traditional playoff series for sports who did not get a playoff tournament last year.

Treasurer

- We have \$80,850 in our bank local account. Roughly \$10,000 of it is being held for a Dylan Buckner memorial. There is \$70,624.60 in the GBN held funds.
- Articles of incorporations have been accepted and we are waiting for an EIN Tax ID number
- After that is awarded, Cari will file for the 501(c)3 designation.
- Fall sports donations came in from all teams but Girls' Varsity Tennis. We've started to get money in for the Winter sports in. Gentle reminders have gone out for those who have not donated.
